Certification, Port Plans Highlight Meeting

Speakers at the 2008 Annual Meeting of Appalachian Hardwood Manufacturers, Inc. announced a pilot project on forest certification and revealed changes in store for the mid-Atlantic ports.

The two sessions were among the business highlights of the 80th Annual Meeting of AHMI at the Marco Island Marriott, Marco Island, FL. More than 160 members and spouses gathered for the event.

"Our business sessions had a keen focus and socially, the weather was perfect," said Tom Inman, AHMI president. "I was extremely pleased by our attendance this year and the valuable information we

A key presentation was from the Sustainable Forestry Initiative and the announcement of a pilot project with AHMI to offer forest management and chain of custody certification for AHMI members. The AHMI Board of Trustees approved the plan in January which gives AHMI members access to a third-party audited certification program at a substantial savings.

AHMI has been working for more than one year on a group licensing project to assist members seeking certification. AHMI has met with SFI and Forest (See Meeting on page 3)

Rick Armstrong of Homer Gregory Inc., Morehead, KY, was named the chairman of Appalachian Hardwood Manufacturers, Inc. at the 2008 Annual Meeting. He received the gavel from John Crites of Allegheny Wood Products, Petersburg, WV, at the AHMI Chairman's Banquet.

In his closing remarks to AHMI members during the Annual Meeting, Crites looked back on all of the change during the past two years. Markets for hardwood lumber have expanded around the world, the American lumber industry is shrinking, and AHMI transitioned to new staff and programs.

Stewardship Council since early 2007. Inman said he hopes to have a similar arrangement later this year with FSC.

"AHMI is not advocating one program over another and hopes to have every opportunity available to our members so they can decide which works best for them," he said.

AHMI has hired a consultant to offer certification training workshops on both programs. These seminars are set for March 20 in Knoxville, TN, and April 17 in Morgantown, WV. Details on the workshops is available on page 3 of this newsletter and a registration form is on page 8.

Inman updated the attendees on the Appalachian Hardwood Verified Sustainable program. Announced in July 2007, the program provides letters, certificates and documentation of the sustainability of the Appalachian Hardwood Forest.

"Verified Sustainable will continue to meet the needs of members whose customers are seeking sustainability documentation," Inman said. "We have printed more than 12,500 certificates that have been distributed around the world."

Verified Sustainable is available to all AHMI members to provide "green" sourcing documentation.

The Saturday business session was highlighted by reports from the major mid-Atlantic port authorities in Maryland, Virginia and North Carolina. Three

tion and sales, coal mining and sales, the manufacturer of aluminum and steel trailers, and bodies and real estate holdings.

In 1994, Mr. Harless and partner, C. Fred Shewey gave the employees of International Industries, Inc. stock and the company became employee owned to continue the legacy and desire to provide for the future of the employees and their families.

"Buck Harless is truly one of the eagles that soars in this region and we honor you for your foresight, commitment and devotion to this industry," Crites said. He presented Harless with a carved eagle from West Virginia artist John Garton.

"I remember in 1949 I was approached by the members of AHMI who said we have a problem and want you to go to Washington on our behalf," Harless said. "This association has been a wonderful thing to come together, solve problems together and work together on behalf of the industry. Thank you so much."

representatives shared about each of their port systems and plans for the future.

Rick Schiappacassee of the Maryland Port Authority said the Port of Baltimore said the facility is more than 300 years old and handles pulp, paper, automobiles, rolling stock and millions of containers annually. The port has six terminals and is served by rail and interstate highway.

Mike Jones of the Virginia Port Authority in Norfolk, VA, said the port is one of the largest on the East Coast and served by more than 45 shipping lines. The port has five terminals including an inland service and has seen growth in both the volume of containers and cargo in 2007. The

Glenn Carlson of the North Carolina Port Authority in Wilmington, NC, said the ports at Wilmington and Morehead City are smaller than their competitors to the north but North Carolina focuses on service. He said an intermodel facility near Charlotte provides quick service at affordable rates to the port.

All three said expansion plans are underway to increase the size of each facility and dredging the channels to allow larger ships to serve the ports. The larger ships will dramatically increase the number of containers shipped from each.

The panel was asked about container availability and freight rates. The three agreed that containers will continue to be difficult to secure in 2008 as imports are off and exports of U.S. goods rise.

Appalachian Hardwood Manufacturers, Inc. has entered into a pilot program with the Sustainable Forestry Initiative to offer forest and product certification to members.

AHMI and SFI staff formerly signed the agreement at the 2008 AHMI Annual Meeting. The program offers

"This is another tool for companies to use in the marketing efforts," said Rick Cantrell, SFI vice president. The SFI board has been working diligently to gain acceptance with consumers.

"We want to be recognized as the most credible certification system in the marketplace," he said. "We make sure that all of our claims are backed up with credible data."

SFI has begun a widespread marketing campaign that is showing results. "We have seen a tremendous increase in interest over the past two years with a 750 percent increase in chain of custody participants," Cantrell said.

SFI is also gaining ground in the forest with more than 8.5 million acres added into the program in 2007.

"There is better recognition of SFI in the marketplace and people are getting more involved in our program," he said.

SFI has developed a group licensing discount for AHMI members and will assist AHMI in developing a

Certification Workshops Offer Answers

Appalachian Hardwood Manufacturers, Inc. will offer two one-day regional Certification and Labeling Short Courses designed specifically for members of AHMI to quickly educate participants about their options when it comes to certification and labeling.

The professional facilitators will outline the unique characteristics of each standard, how member companies could achieve conformance with the standards, which labeling and claims could be made, and what the costs of implementation and auditing would be. There will be consideration of the Sustainable Forestry Initiative, the Forest Stewardship Council and the American Tree Farm Systems.

The course is designed for mill managers, land managers and procurement personnel and will provide copies of the most recent standards and a presentation with notes that each participant can take away from the course.

The programs begin at 10 a.m. and the \$75 fee includes materials, lunch, & breaks. Attendance is



system to demonstrate legality, implement verification, develop a framework for discussions with auditors and research pre-packaged implementation programs.

"For AHMI members whose customers are demanding certified products, we believe this pilot program will enable them to enroll in a certification program that is less expensive, easier to enroll and is credible," said Tom Inman, AHMI president. "Every company will have the opportunity to make their own decision about enrollment."

AHMI continues to discuss a similar arrangement with the Forest Stewardship Council with hopes of developing a program later in 2008.

AHMI will send SFI enrollment materials in March. Enrollment fees are prorated based on date of registration.

March 2008 The Standard - Appalachian newsletter - 5 Verified Sustainable Receives AHFA Support

HIGH POINT, N.C. – The American Home Furnishings Alliance announced recently it will recognize the Appalachian Hardwood Verified Sustainable program for meeting the certified wood requirement in its Sustainable by Design program.

Sustainable by Design is a certification program designed to help AHFA member companies create a corporate culture of conser-



vation and environmental stewardship by integrating sustainable business practices into manufacturing operations and sourcing.

Companies participating in the program are asked to analyze the environmental impact of their operations, raw materials and finished products. Then they must take specific steps to minimize their "environmental footprint" and develop goals for continual improvement. One component is using certified lumber in furniture production. Sustainable by Design requires companies to use a minimum of 3 percent certified lumber.

"There is an increasing demand among U.S. manufacturers for sustainable resources," notes AHFA Vice President Bill Perdue. "However, according to 2005 data, only about 7.2 percent of the world's forest areas are certified, and only about 19 percent of the 748 million acres of forest land in the United States is certified. This leaves companies that are striving to meet a certified lumber requirement in a bind."

AHMI launched its Appalachian Hardwood Verified Sustainable program in July 2007 in an effort to increase the supply of sustainable lumber available to woodworking industries. The Verified Sustainable program gives AHMI members documents verifying that the timber was sourced from the Appalachian Region. A U.S. Forest Service analysis found that the growth to removal ratio in the Appalachian Region is more than 2.29 to 1.

"The AHMI program is focused on ensuring sustainable forestry practices and, in fact, is the only program in the world that can verify its sustainability claims with real numbers," adds Perdue.

AHFA also recognizes Forest Stewardship Council (FSC) and Sustainable Forestry Initiative (SFI) certification programs.

Distributors Hear Of FL Forests, Markets

MARCO ISLAND, FL - The Appalachian Hardwood Manufacturers, Inc. Distributors Division learned about the forests and markets for forest products in Florida during the AHMI Annual Meeting.

The Division held its own session on Saturday and heard from Florida Forestry Association Executive Director Jeff Doran. He said Florida's forests are located in the central and northern portions of the state and two-thirds are owned by private landowners. He said 18 of Florida's 67 counties are majority forested with hardwoods amounting to 7.8 million acres and softwoods at 7.3 million acres.

Doran noted that state has purchased more than \$3 million in forest lands over the past 10 years. The state is battling development and discovering that more than 40,000 acres of timberland is converted annually and estimates are another 2.5 million acres will be developed by 2030.

"Timber remains a major part of the Florida economy," Doran said. More than 133,000 people are employed in the industry generating \$16.6 billion an-

nually.

Doran shared insight about explosive of manufacturing and business in China. He traveled to China recently with Florida business officials and counted more than 50 construction cranes from his hotel window in Shanghai.

"Much of their wood comes from Malaysia and other countries we consider to be rainforest and are the largest logs you will ever see," Doran said. To compete with these other countries, the United States must consider the taxes and restrictions on business.

Other opportunities for landowners and forest products companies are carbon credits and markets for trading of pollutions credits. These incentives to help the industry survive into the future.

"For these programs to be successful, they have to be broken down into terms and plans that people can understand," Doran said.

He summarized his remarks that development and land use changes are a real threat to Florida timber while the future continues to look bright.
