AHMI/HMA Fall Meeting, Tours Set In Ohio

Appalachian Hardwood Manufacturers, Inc. and the Hardwood Manufacturers Association are hosting a fall meeting and tour on Oct. 12-13 in central Ohio.

The meeting headquarters will be the Holiday Inn Express & Suites in Zanesville, OH. The tours begin on Oct. 12 departing from the hotel at 7:30 a.m. The first stop is Yoder Lumber Co. kilns and dimension facility in Berlin, OH. Yoder Lumber is a third generation family-owned business in the heart of the Appalachian hardwood region.

The second stop is HW Chair in Millersburg, OH. The company produces residential dining room chairs and chairs for the hospitality industry, colleges and libraries.

After lunch, the tour moves to Yoder Lumber Co.'s operation in Buckhorn. This facility has two sawmills, drying facilities, a predryer, lumber storage, and an automated lumber sorting line. Yoder's Millwork and Distribution warehouse and storefront are located here.

The group will return to Zanesville for a reception and dinner at the city's convention bureau office. (Shuttles are available from the hotel.) There will be industry roundtables following dinner.

The second day begins at 9 a.m. at Brenneman Lumber Co. (Participants are asked to drive on their own because the meeting will end after the tour.) Brenneman is a family owned and operated business with yard and offices located in Mount Vernon, OH.

Boiler Owners Must Notify EPA By 9/17

A notification deadline from the Environmental Protection Agency for wood-fired boiler operators is Sept. 17.

The EPA requires owners of Area and Major Sources to complete the 40 CFR Part 63 Subpart JJJJJJ by Sept. 17 for those subject to the National Emission Standards for Hazardous Air Pollutants (NESHAP) for Industrial, Commercial, and Institutional Boilers.

Facilities are considered Area Sources if they emit up to 10 tons per year of any hazardous air pollutant. Facilities are considered Major Sources for HAPs if they emit 25 tons/year or more of combined HAPs.

The way I see it...

...our new toolkit for hardwood companies who plan to become Forest Stewardship Council certified is extremely helpful.

The detailed handbook is a partnership between Appalachian Hardwood Manufacturers, Inc., the National Wood Flooring Association and the RainForest Alliance. It was developed by Jason Grant and funded by the U.S. Forest Service Wood Education Resource Center.

AHMI has been involved with the certification systems for several years. We have offered workshops, training and materials.

Approximately 20 percent of AHMI members are certified, with the majority to the FSC standard and others to the Sustainable Forestry Initiative and Program for the Endorsement of Forest Certification systems.

The new toolkit is tailored to hardwood sawmills and wood flooring manufacturers, but much of the contents apply to hardwood distributors and other types of secondary manufacturers. The toolkits provide detailed guidance, sample language, forms and templates to make it easier and more cost-effective for companies to prepare for FSC certification and audits. There are also sample controlled wood risk assessments for each state.

A workshop will be held during the National Hardwood Lumber Association convention in Nashville to introduce the "Toolkits for FSC Certification." It is set for Thursday, Sept. 22 at 3 p.m. in Ryman Studios J&K beside the main trade hall.

The workshop is designed for companies that are contemplating certification to the FSC Chain of Custody and/or Controlled Wood standards.

Online training, webinars and regional training sessions will be announced at the workshop. It is open to all convention attendees.

Hardwood Federation Fly-In Is Set Oct. 4-5

The 2011 Hardwood Federation Fall Fly-in is Oct. 4-5 and industry leaders are encouraged to make this important trip to Washington to meet face-to-face with members of Congress.

There are four key topics that are vital for industry survival: protection and funding of the Lacey Act, expanding pro-hardwood government procurement policies, putting a halt to new regulatory costs on an industry already in recession, and encouraging proper management at the USFS.

Featured speakers are Congressman Larry Kissell (D-NC) and Senator Debbie Stabenow (D-MI), Chairwoman of the Committee on Agriculture, Forestry, and Nutrition. HFPAC will also sponsor two receptions: one for Republicans and one for Democrats.

FFRC Opens DC Office

The Federal Forest Resource Coalition announced the opening of a permanent office in Washington, a key element in efforts to improve the performance of Federal timber sale programs. Bill Imbergamo will serve as the Coalition's Executive Director.

"The wood products industry depends on healthy forests for our livelihood. For too long, we've watched the Forest Service and other Federal lands adopt a passive approach to management which threatens our mills and the health of their forests," said Howard Hedstrom, President of Hedstrom Lumber in Grand Marais, Mn., who will serve as the Coalition's President.

FFRC is a unique national coalition of small and large companies and regional trade associations whose members manufacture wood products, paper, and renewable energy from Federal timber resources.

Appalachian Wood Pellets Has Open House

KINGWOOD, WV - Appalachian Wood Pellets officially opened its manufacturing plant here in August.

Owned by John Crites II and wife, Shelly, the facility is adjacent to the Allegheny Wood Products sawmill and utilizes its green sawdust. The sawdust is delivered by conveyer to the plant where it is separated, dried and pelletized under pressure. The pellets are packed in 40-pound bags and delivered to retailers under the name brand Appalachian Wood Pellets.

The plant began production earlier this year and employs 10 people in Preston County. The company is a member of AHMI's Consumer Division and has the Appalachian Hardwood Verified Sustainable seal printed on its packages.

More than 100 people attended the open house including West Virginia Governor Earl Ray Tomblin, WV House and Senate members, local elected officials and wood industry leaders. Tomblin thanked the Crites family for their commitment to the state and local economies.

Crites thanked AWP employees for their hard work completing the plant.

AHMI Offers Green Resource Solutions

Appalachian Hardwood Manufacturers, Inc. has six offerings for members who are seeking "green" documentation for their Appalachian hardwood products.

AHMI has partnerships with the WoodNet Market Council and Columbia Forest Products to provide access to Forest Stewardship Council Group Certification to AHMI members. The two companies currently hold group certificates with participants across the eastern U.S.

AHMI began offering pre-audit services from a contractor in 2008 for members seeking Sustainable Forestry Initiative, Forest Stewardship Council or Program for Endorsement of Forest Certification approval. SFI discounted its fees for AHMI members.

The association also developed a relationship with NSF to provide auditing for all of the schemes at a discounted rate for AHMI members.

The Appalachian Hardwood Verified Sustainable program offers certificates and letters verifying the resource is from the sustainable Appalachian Hardwood forest. AHMI Meets With AWI

Appalachian Hardwood Manufacturers, Inc. will have two meetings in two months with members of the Architectural Woodworking Institute.

"There were millwork, plywood and casework producers in attendance and most had not heard of the checkoff," Inman said. "They were in favor of any promotion of American hardwoods to consumers."

The meeting included a roundtable where each person discussed issues in their area. Most complained about decreased work, lack of credit and slow paying customers.

Inman will also attend the 2011 AWI National Convention in Charlotte on Oct. 26-28. The program includes business sessions on revitalizing manufacturing, economic recovery and strategies to retool for success.

NHLA Offers Lumber Drying Short Course

Operating a lumber drying facility, especially one drying hardwood lumber, requires special skills. A significant amount of lumber can be degraded or damaged during drying when proper techniques are not used.

A Basic Hardwood Lumber Drying Course is set for Nov. 7–8 at the Brooks Forest Products Center at 1650 Ramble Road, Blacksburg, VA. This course is for beginning operators and supervisors drying hardwood lumber using air-dry yards, pre-dryers, steam or dehumidification dry kilns. The program will cover practical techniques for the efficient and effective operation of dry kilns. The program will include moisture measuring and the use of sample boards; kiln and predryer operational techniques; drying schedules; causes and cures for drying defects, special drying techniques, quality control procedures and more. Classes will begin at 8 a.m. and end at 4:30 p.m.

This course is sponsored by the Department of Wood Science at Virginia Tech, Virginia Coop-



erative Extension, the National Hardwood Lumber Association and the Virginia Forest Products Association.

Dr. Brian Bond has extensive experience in working closely with the wood industry as an extension specialist and consultant in the areas of lumber drying, wood and moisture relations, and sawmill efficiency. The seminar fee includes course materials, NHLA Rules Book, a Certificate of Completion and lunch each day. Please bring a notebook and a grading stick, if you have one.
