'17 Fly-In Bigger, Busier Than Ever

By Dana Lee Cole, Hardwood Federation In an increasingly polarizing political environment, making sure the hardwood story and how existing and proposed federal policies impact our businesses is at the forefront of our politicians' minds is vital.

The 2017 Hardwood Federation Fly-In brought hardwood industry leaders to Washington to tell their stories and relate the industry's message directly to the Members of Congress. Sixty representatives from across the U.S. came to Washington, D.C. on Sept. 13 –our largest attendance in recent memory.

Appalachian Hardwood Manufacturers was very well represented by staff and membership...and its Board met in conjunction with the Hardwood Federation Board.

Fly-In participants were a great mix of knowledgeable veterans and eager new faces. They stormed the Hill in small groups and visited as many congressional offices as possible to make a real difference!

Hardwood Federation representatives attended almost 100 meetings with Members of Congress and staff. Sixty-four (64) meetings were held with members of the U.S. House of Representatives and thrity-five (35) more meetings with those in the U.S. Senate – more than 1/3 of the total in the Upper Chamber.

Marco Marriott Survives Irma; AHMI Meeting Set

The 2018 Annual Meeting of Appalachian Hardwood Manufacturers, Inc. is set at the JW Marriott Marco Island on Jan. 17-21, 2018.

The resort suffered only minor damage from Hurricane Irma and is completing final repairs this week. It opened for visitors on Oct. 2 and will be fully operational by the end of the week.

This is the third visit to Marco Island for AHMI and the first since the property became a JW Marriott in 2016. It is set on three miles of private white sand beach on the Gulf of Mexico. They are completing a \$320 million renovation, providing guests with luxurious accommodations, 10 restaurants, the Spa by JW® and two 18-hole championship golf courses.

The AHMI Annual Meeting is earlier than usual for 2018 to take advantage of availability and rates at the resort. Weather in January is typically mid-80s and sunny.

...the joint meeting of AHMI and the Hardwood Federation was a HUGE hit. We had a great crowd, more than 100 meetings with Congressional members and staff and told our message to the people who can help or hurt us.

There were almost two dozen AHMI members and companies represented from most of our states. The training session gave us the key information and we hit the Hill to educate staff and Congress.

We were able to meet with many Representatives and only a few Senators and they listened. (A full report on the issues is on the 1st and 5th pages of this newsletter.) The top issues for AHMI members were Sawmill Residuals and Federal Forest Reform.

The hardwood industry supports House and Senate bills that give the same tax incentives to high efficient wood waste burning systems that are afforded to wind and solar. Biomass should get the same breaks as other "green" energy.

National forest fires should be treated as the disasters that they are and fought with FEMA money rather than US Forest Service budgets. The western fires are burning up dollars needed for federal forest management.

These issues and others received nods of approval from the Congressional leaders. We will watch to see if the votes follow.

Thank you to each AHMI member who took the time and expense to attend the Fly-In. Your support makes a difference having an impact in Washington. Please make plans to join us in September 2018 as we continue to work for positive change for the industry.

Symposium To Discuss Oak Decline

Appalachian Hardwood Manufacturers Inc. invites you to participate in the 2017 Oak Symposium on Oct. 24-26 at the University of Tennessee in Knoxville. There are two days of seminars from leading researchers and academia and a third day for forest tours.

(This is overlap with the National Hardwood Lumber Association Convention in Nashville but encourage you to review the schedule and consider the first day of presentations.)

Sustaining the Oak resource is important to public and private land managers in the eastern United States. Oaks are threatened by natural succession, changes to disturbance regimes, urban development, and lack of critical knowledge for management.

The symposium will be hosted by the University of Tennessee (UT), Department of Forestry, Wildlife, and Fisheries with sessions on forest health, emerging economic markets, silviculture for climate change, managing for Oak regeneration, Oak decline, and prescribed burning.

During this workshop, SFI will present information on these market trends, and how an organization can achieve third-party certification to the SFI Standard.

4 - October 2017 - Appalachian Sustainable Inman Updates PY On Verified Sustainable

STATE COLLEGE, PA - Appalachian Hardwood Manufacturers, Inc. President Tom Inman spoke at the September meeting of the Penn York Lumbermen's Club sponsored by AHMI member Walker Lumber Co.

More than 100 people attended the meeting of lumber producers, distributors and secondary manufacturers from the northeast. The session preceded the Pennsylvania Forest Products Association Annual Meeting.

Inman updated the group on the 10th anniversary of the Appalachian Hardwood Verified Sustainble promotion and new details from the US Forest Service. The ratio of growth to removal in the region has improved to 2.4 and more than 65 million acres of forests are growing in the Appalachian region.

Almost 75 percent of AHMI members participate in AHVS and the AHMI Board recently approved plans to certify the program in 2018. Inman also explained the report shows a decline in oak and hickory growth and rise in maple and beech.

We also were able to visit with members at our Hardwood Federation PAC reception and breakfast. The meetings on Capitol Hill covered five of the Federation's priority issues:

• **Federal Forestry Reform** – H.R. 2647 the *"Resilient Federal Forests Act of 2017"* from the only Forester in Congress, Rep. Bruce Westerman (R-AR), has been re-introduced in the House and continues to address badly needed reform to federal land management, while also considering concerns regarding forest fire funding that currently consumes over 50% of the US Forest Service budget;

• **Tax Reform** – HF supports a Federal tax system that maintains a healthy economic environment for small, medium, and large companies, as well as family owned and operated businesses. Reform of the tax code should include S-Corp. benefits – including protecting assets, pass-through taxation, straightforward ownership transfer, employee stock ownership plans and heightened credibility, a reduced estate tax, and tax structures that benefit forest land owners;

• **Sawmill Residuals** – HF supports the Biomass Thermal Utilization Act (H.R. 3161 and S. 1480) which qualify high efficient biomass heating systems for the same investment tax credits (30% of install cost) as other renewables. HF also supports the Community Wood Energy Program (CWEP) included in the Farm Bill.

• **Tall Wood Buildings** – HF Supports the Timber Innovation Act (TIA) (H.R. 1380 and S. 538) which helps develop new markets for wood products using Cross Laminated Timber (CLT).

• **MAP and FMD** – HF strongly supports full funding for the Market Access Program (MAP) and Foreign Marker Development (FMD) program as authorized in the 2014 Farm Bill and full funding going forward, including in the 2018 reauthorization of the Farm Bill.

During the annual Opening Reception at the Marriott Marquis following a full day of Board Meetings, we were fortunate to hear a few words from Sen. John Tester (D-MT). He is a generational family farmer and music teacher and understands the hard work of our industry as a man of similar agricultural and manufacturing interests. He has seen first-hand the devastation of the catastrophic wildfires increasingly affecting the West and just the week prior was on his ranch surrounded by smoke.

Following the Wednesday reception, Rep. Tom McClintock (R-CA, 4), Chairman of the Natural Resources Subcommittee on Federal Lands, spoke to the group during dinner. He gave an impassioned speech on the need for better Federal Forest Management as he has also seen first-hand the effects of wildfire in the West as it has, and continues to, burn vast swatch of his home district. The memorable words were followed by a rousing standing ovation from our HF attendees and many of the audience asked for copies of his speech.

For the second year in a row the evening was capped by a stunning night tour of the U.S. Capitol, lead this year by Rep. Virginia Foxx (R-NC, 5), who proved to be a wealth of knowledge. The visit featured visits to the Speaker's Balcony with its glorious views of Washington D.C. at night, the rare opportunity to sit on the Floor of the House of Representatives, and time exploring the many gorgeous rooms and old Chambers. A special treat was the after-hours visit to the Lindy Claiborne Boggs Women's Reading Room, which during the day, or when Congress is in session at the Capitol, is accessible to women only. This historical space was also where John Quincy Adams died before its current occupancy. You never know what will happen during the Hardwood Federation Fly-In!!

We hope everyone enjoyed their time on the Hill, learned something new, and came away with a new appreciation of how their engagement can make a difference on public policies made in Washington. I encourage everyone reading this to join us for next year's Fly-In so we can reach more offices and be even more effective. We hope you can join us!

Wood Waste Plant Set For Southern WV

SMOOT, W. Va. - The newly-formed PPD of WV One will build a \$73 million synthetic fuel plant in Greenbrier County, West Virginia, to convert solid waste materials to diesel fuel and biochar, a charcoal used in soil for agriculture.

The resource for the plant will primarily be wood waste from the region's growing forestry and wood products industry. The facility will utilize a clean energy system that produces an inexpensive hydrogen gas stream on demand from biomass and waste sources.

The project will create approximately 160 construction jobs, with an additional 60 to 100 fulltime jobs once the plant enters operation. Construction is scheduled to begin in late winter or early spring.
